

Circulating and Filing Schedule continued:

(If the Secretary of State notifies the county to determine the number of qualified voters who signed the petition on a date other than 05/10/08, the last day is no later than the thirtieth working day after the county's receipt of notification). (Elec. Code § 9030(d)(e)).

- f. If the signature count is more than 477,369 or less than 412,273 then the Secretary of State certifies the petition as qualified or failed, and notifies the counties. If the signature count is between 412,273 and 477,369 inclusive, then the Secretary of State notifies the counties using the random sampling technique to determine the validity of **all** signatures (EC §9030(f)(g); 9031(a)) Thursday, 07/03/08*

- g. Last day for county to determine actual number of all qualified voters who signed the petition, and to transmit certificate with a blank copy of the petition to the Secretary of State. (Elec. Code § 9031(b)(c))..... Friday, 08/15/08

(If the Secretary of State notifies the county to determine the number of qualified voters who have signed the petition on a date other than 07/03/08, the last day is no later than the thirtieth working day after the county's receipt of notification.) (Elec. Code § 9031(b)(c).)

- h. Secretary of State certifies whether the petition has been signed by the number of qualified voters required to declare the petition sufficient (Elec. Code §§ 9031(d), 9033) Tuesday, 08/19/08*

IMPORTANT POINTS

- California law prohibits the use of signatures, names and addresses gathered on initiative petitions for any purpose other than to qualify the initiative measure for the ballot. This means that the petitions cannot be used to create or add to mailing lists or similar lists for any purpose, including fundraising or requests for support. Any such misuses constitutes a crime under California law. Elections Code section 18650; *Bilofsky v. Deukmejian* (1981) 124 Cal.App.3d 825, 177 Cal.Rptr. 621; 63 Ops.Cal.Atty.Gen. 37 (1980).
- Please refer to Elections Code sections 100, 101, 104, 9001, 9008, 9009, 9021, and 9022 for appropriate format and type consideration in printing, typing and otherwise preparing your initiative petition for circulation and signatures. Please send a copy of the petition after you have it printed. This copy is not for our review or approval, but to supplement our file.
- Your attention is directed to the campaign disclosure requirements of the **Political Reform Act of 1974**, Government Code section 81000 et seq.
- When writing or calling state or county elections officials, provide the official title of the initiative which was prepared by the Attorney General. Use of this title will assist elections officials in referencing the proper file.
- When a petition is presented to the county elections official for filing by someone other than the proponent, the required authorization shall include the name or names of the persons filing the petition.
- When filing the petition with the county elections official, please provide a blank petition for elections official use.





The Attorney General of California has prepared the following title and summary of the chief purpose and points of the proposed measure:

ANIMAL LICENSE FEES. STATUTE. Mandates that all cities, counties and governmental entities within the state of California are prohibited from charging any animal licensing or permit fees in excess of \$50.00. Entitles senior citizens and Medicare and Medi-Cal recipients to a 50 percent fee reduction. Prohibits localities from enforcing local law conflicting with initiative statute. Summary of estimate by Legislative Analyst and Director of Finance of fiscal impact on state and local government: Unknown net revenue loss or gain to local governments depending on the number of animals licensed under the measure. (Initiative 07-0057.)



Initiative Measure To Be Submitted Directly To The Voters

The Attorney General of California has prepared the following title and summary of the chief purpose and points of the proposed measure:

TO THE HONORABLE SECRETARY OF STATE OF CALIFORNIA

We, the undersigned, registered qualified voters of California, residents of _____ County, hereby propose amendment to the Health and Safety Code, relating to licensing of animals, and Petition the Secretary of State to submit the same to voters of California for their adoption or rejection at the next succeeding primary or general election, or at any special statewide election held prior to that primary or general election, or as otherwise provided by law. The proposed statutory amendment, Animal License Law reads as follows:

Section 1. Animal License Law

The state of California mandates that all cities, counties and any governmental entities within the state shall as a matter of public health not require any animal licensing or permit fees or assessment or taxes of any sort or combinations thereof to total any amount in excess of \$50.00. This is a public health issue intended to encourage the licensing of pet animals requiring rabies vaccinations. Senior citizens or individuals receiving MediCare or Medi-Cal benefits shall be entitled to a reduced rate of one half of the licensing or permit fee. Cities and Counties and other governmental entities within the state of California shall not enforce or enact any law or ordinance that would remove this mandate enacted by the citizens of the state of California.
