ONLINE DISPUTE RESOLUTION FORUM



In late June CNDR co-hosted An **International Conference on Online Dispute Resolution** | ODR2014 brought together the technology and dispute resolution communities, legal practitioners, mediators and other ADR professionals, academic researchers, financial institutions, ecommerce companies and social media companies, members of judiciaries worldwide, and social justice advocates using innovative technologies to leverage change. The week long Forum began with the first ever **Dispute Resolution Hackathon** at Code for America's San Francisco office, a non-profit that helps residents and governments harness technology to solve community problems. Over the course of the weekend, seven teams put together presentations on an issue, the proposed tech solution, how it addresses the issue and its potential for scalability. Themes addressed included the collaborative economy, privacy, cyberbullying and harassment.

ODR2014 continued with behind the scenes **tours of Facebook, Google and eBay in Silicon Valley**. An offshoot of the tech boom has been the creation of work environments and cultures that empower and stimulate employees. Several on the tour commented on what they saw as enviable ways to work, play and collaborate with co-workers, and how the work culture encouraged creativity and productivity.

The UC Hastings Day, called "**Breaking Mad: How the Collaborative Economy's Best Companies are are Turning Customer Disputes into Brand Gold**", included leaders from Ecommerce, consumer protection organizations, social media and dispute resolution speaking on best practices in customer service, resolving consumer disputes and managing brand reputation through efficient and effective dispute resolution systems. UC Hastings Dean and Chancellor Frank Wu, Center for Negotiation and Dispute Resolution Director (CNDR) Sheila Purcell and ABA Dispute Resolution Section Chair and UC Hastings '91 Ruth Glick welcomed forum attendees from all over the globe, including India, South Africa, Greece, the UK and China, just to name a few. Highlights included a keynote by the Director General of Consumers International, Amanda Long, an onstage interview about Diversity in Tech with Mitch Kapur, inventor of the Lotus spreadsheet, and lively presentations about best practices at Task Rabbit, AirBnB, eBay, Elance, Net Neutrals, Poshmark and Facebook.

ODR2014, was the thirteenth ODR Forum and the first to be held in the United States. The ODR Forum has previously been held around the world, including Geneva, Chenni, Buenos Aires, Hong Kong, Cairo and Prague.

The Stanford days began with Law School Dean Mary Elizabeth Magill and Stanford's Martin Daniel Gould Center for Conflict Resolution Program Director Janet Martinez welcoming ODR2014 participants, followed by keynotes, panels and breakout sessions with authorities in law, dispute resolution, international ODR and legal education. UC Hastings Professor of Law and Director of the Institute for Innovation Law, Robin Feldman, presented, along with Kent Walker, General Counsel of Google, on Patent/IP disputes. Former CNDR Director and current Director of the Community Relations Service within the Department of Justice, Grande Lum, presented on ODR in Government.
