Lisa Zolotusky examines the prevalence of caesarian birth and questions the incentives doctors currently have to perform this invasive procedure. Deborah Weiss's article about gender discrimination in employment explores pervasive stereotyping and its implications for implementing Title VII successfully and recommends a modified affirmative-action paradigm to limit the impact of stereotypes in workplaces.

Selecky*, which discusses the importance of women's access to emergency contraception following rape or sexual assault.

I am thrilled to be presenting two articulate and divergent positions regarding HIV criminalization in one issue. I hope that our readers appreciate the dialogue between Angela Perone and Erin McCormick as much as I and *HWLJ's* editors have while editing these pieces.

Continuing on our theme from 24:1, there are two articles about the system of laws surrounding domestic violence in the United States. Robin Runge explores the history of the Violence Against Women Act and puts in context the 2013 reauthorization of that important legislation. Claire Wright recommends that the United States follow international law and psychological analysis to better protect victims of psychological domestic violence or "intimate terrorism."
