Greetings from the Dean

To the members of Hastings College of the Law Alumni Association:

Our 85th academic year is about to open. As on so many other occasions in the post-war years, we expect to have both the largest First-Year Class and the largest Student Body, in Western America.

Half of our new students will find it necessary to attend all of their classes during afternoon hours. There will be waiting lines for chairs in the Charles W. Slack Memorial Library. The supply of lockers will be lamentably deficient. But as in all of the other years since 1878, *no qualified applicant for admission to the College will be turned away, for lack of space.*

We cannot say as much for Professors! For lack of offices, this year's Faculty can be no larger than that of 1961-62; and for the same reason, the new First-Year Class must be divided into two sections of about 225 each, rather than into three of 150.

Alterations in our no-longer-new building will make it possible for us to staff two sections of all three classes, in 1963-64, when several new members will be added to the 65-Club. Meanwhile, Professor Edward S. Bade (69), a Real Property Specialist who taught at the University of Minnesota Law School from 1932 until 1961, will join the group.

So likewise, will Professor Clarence M. Updegraff (69), a nationally recognized authority on Labor Law and Arbitration, who already has completed 45 years as a teacher of law, 36 of them at the State University of Iowa.

History was made in the United States Senate, on August 8, 1962, when Senator Morse (Oregon), described the Faculty of Hastings Law College as "greater than Harvard, Yale, Columbia, Michigan, Minnesota, Chicago or Wisconsin, and all the rest." Senator Clair Engle, '33, (California) unblushingly agreed with him. (108 Congressional Record, 14958.)

Hiring at 65

At the Hastings College of Law of the University of California, Dean David E. Snodgrass has pulled a switch on the usual hiring procedure: he has hired professors only after they've been forced out of their jobs at other schools because of compulsory retirement! While most colleges "fire" at 65, Hastings hires at 65.

Dean Snodgrass puts the proposition bluntly: "This notion that a man is through just because he has celebrated an arbitrary number of birthdays is idiotic."

The permanent faculty at Hastings has become known as the Sixty-five Club because each man is over 65—at least. The oldest professor was hired in 1957 at the age of 80. The Sixty-five Club has converted Hastings from a relatively obscure school to one which is the largest approved law school west of Chicago and one of the most respected in the nation.

Roscoe Pound, one of America's most famous professors of law, and once Dean Snodgrass' law dean at Harvard, commented on the Hastings faculty, "On the whole, I am inclined to think you have the strongest law faculty in the country."

The collective experience of the Hastings faculty cannot be matched by any other law school. Five of the members of the Sixty-five Club are former deans of major university law schools. Nearly

every member of the faculty is the author of casebooks and textbooks used in law schools from Los Angeles to Boston.

A rising young professor of law recently applied for a full-time teaching position at Hastings and got this reply from Dean Snodgrass:

"We are complimented by your application. However, it is not our policy to engage men so young for other than administrative or part-time positions on our teaching staff. Our full-time professors must be at least 65 years old. If at that age or older you should still like to teach at Hastings, I or my successor will be glad to reconsider you."

The American Bar Association sent an inspection committee of law-school deans to give Hastings the once-over. How good were its post-65 professors? The inspection committee reported:

"In view of the fact that the faculty are all over 65, we felt that age might have slowed them up. Consequently, we spent some time listening to those who had classes during our visit. The classroom performance in each instance was excellent. . . .

"Your evaluators are of the opinion that the faculty is alert, interested in and insisting upon high standards of legal education and doing an excellent job, not only in the classroom but in public service and research."
